## Nutrena<sup>®</sup> Club Support Program

Is an opportunity for clubs to earn financial support for event sponsorship, awards, educational supplies, or any other promotional or educational effort the club wishes.

### Procedure

- Submit proofs of purchase for **Nutrena<sup>®</sup>** feeds and pet foods with the attached redemption form.
- All proofs of purchase must be counted and submitted in an orderly fashion to be accepted.
  - Designate one person to be responsible for collecting and submitting proofs and redemption forms.
  - Proofs of purchase may be submitted as often as desire.
- Labels dated over one year may not be redeemed .

Forward all requests to the address at the bottom of the request form.



### Proofs of Purchase

- Only **Nutrena<sup>®</sup>** Feeds listed on the redemption form, River Run and Pro Premium Pet Foods are eligible for redemption.
- The only acceptable proofs of purchase for grain products are the sewn-on tags that include the product description.
  - The only acceptable proofs of purchase from the pet foods are the UPC labels from the bags.

### Requesting Funds

- Participating clubs must submit a written request to their **Nutrena<sup>®</sup>** representative stating how the funds will be used.
- Clubs must submit a current membership list along with the redemption form.
  - Clubs must mention **Nutrena's<sup>®</sup>** support on all public information, advertising, and released material.
- The "Nutrena<sup>®</sup> Club Support Program" will remain in effect until cancelled by either party by written notification. The program may be terminated or withdrawn at any time.
